The fund is a qualified 501(C)-3 foundation and donations are tax-deductible (tax I.D. #20-5153144). Reducing educational cost for families who have been dedicated stewards of their community is our goal. During its inaugural year, The Fund covered 22% of the tuition need for families who met the fund requirements of active stewards of the parish. Our goal for the 2007-2008 school year is to fund 40% of the tuition need for applicants who meet scholarship requirements.
